CALL MEETING TO ORDER

Mayor Kittner called the meeting to order at 5:48 p.m.

1. HEAR VISITORS

No visitors came forward to speak at this time.

ITEMS FOR INDIVIDUAL DISCUSSION, CONSIDERATION AND/OR ACTION

2. DISCUSSION AND BRIEFING CONCERNING THE CORONAVIRUS (COVID-19) AND ANY ACTIONS NECESSARY THERETO

Dr. Oubre provided the following:

- Mr. Klump did apply in a timely manner for the balance of the CARES Act grant.
- Vaccine shipped yesterday from Pfizer to outgoing locations. In the first round you will see doctors, nurses and attendants receive the vaccine. The next tier is the nursing home providers and residents. After that, the next group will be first responders.
- As of November 29th, the state health department notified the County that the seven-day average exceeded the fifteen percent total of hospital occupancy, which automatically enforces a fifty percent occupancy in restaurants, retail stores, gyms and other public gathering places.
- Our next scheduled city council meeting is in January.

3. DISCUSSION AND CONSIDER ACTION ON AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH LANGERMAN FOSTER ENGINEERING COMPANY FOR CONSTRUCTION MATERIALS TESTING SERVICES FOR THE FAIRWAY GRAVITY SEWER REPLACEMENT PHASE II

Dr. Oubre provided that we are hiring an engineering firm we have used in the past. This is for construction materials and testing within the Fairway Gravity Sewer Replacement Phase II project. They will monitor the

materials and test where needed. This comes from the bond proceeds for that project.

Councilmember Giddings moved to authorize the City Manager to execute an agreement with Langerman Foster Engineering Company for construction materials testing services for the Fairway Gravity Sewer Replacement Phase II project. Mayor Pro Tem Sober seconded, and the motion passed unanimously by the Councilmembers present.

4. DISCUSSION AND CONSIDER ACTION ON RESOLUTION R-20-20, DECLARING THE 1994 FIRETRUCK EXCESS PROPERTY TO THE CITY'S NEEDS AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MCLENNAN COMMUNITY COLLEGE TO DONATE THE 1994 FIRETRUCK TO THE MCC FIRE ACADEMY IN EXCHANGE FOR WAIVED TUITION FOR WOODWAY'S NEXT TEN FIREFIGHTING TRAINEES

Dr. Oubre provided that the City has the following three options available to dispose of this firetruck.

- Original trade-in when we ordered the new firetruck
- Auction it to highest bidder
- Donate it and get some monetary proceeds in-kind

By donating it to MCC, it helps the region, the basic academy, and in-service training. Chief Crook was able to negotiate value for that truck and the value is that as we send cadets in for the basic fire academy we will receive basically what we would have received as a trade-in for the firetruck.

We are asking you to authorize donating the firetruck to MCC in exchange for waived tuition.

There was a brief discussion.

Councilmember Giddings moved to adopt Resolution R-20-20, declaring the 1994 Firetruck excess property to the City's needs and authorizing the City Manager to execute an agreement with McLennan Community College to donate the 1994 Firetruck to the MCC Fire Academy in exchange for waived tuition for Woodway's next ten firefighting trainees. Mayor Pro Tem Sober seconded and the motion passed unanimously by the Councilmembers present.
