CALL MEETING TO ORDER

Mayor Kittner called the meeting to order at 5:33 p.m.

ITEMS RELATED TO PROPOSED 2021/2022 ANNUAL BUDGET AND PROPOSED 20201AD VALOREM TAX RATE

3. PUBLIC HEARING ON PROPOSED 2021/2022 ANNUAL BUDGET

Mayor Kittner opened the public hearing on the proposed 2021/2022 annual budget. With no one present to speak in favor of or in opposition to the proposed budget, Mayor Kittner closed the public hearing.

4. A. DISCUSSION AND CONSIDER ACTION ON ORDINANCE 21-06, ADOPTING THE 2021/2022 ANNUAL BUDGET

Dr. Oubre presented this item and asked that they adopt the ordinance approving the proposed 2021/2022 budget that will begin October 1, 2021 and runs through September 30, 2022.

Councilmember Qourzal moved to adopt Ordinance 21-06, adopting the City of Woodway 2021/2022 annual budget. Councilmember Russell seconded, Mayor Kittner read aloud the caption of the ordinance as required. Voting in favor: Mayor Kittner, Councilmember Qourzal, Councilmember Mercer, Councilmember Russell and Councilmember Cook. The motion passed unanimously by the Councilmembers present.

B. DISCUSSION AND CONSIDER ACTION ON RATIFICATION OF THE PROPERTY TAX REVENUE INCREASE REFLECTED IN THE BUDGET

Councilmember Mercer moved to ratify (approve) the property tax revenue increase reflected in the budget. Councilmember Cook seconded the motion. Voting in favor: Mayor Kittner, Councilmember Qourzal, Councilmember Mercer, Councilmember Russell and Councilmember Cook. The motion passed unanimously by the Councilmembers present.

5. PUBLIC HEARING ON PROPOSED 2021 AD VALOREM TAX RATE

Mayor Kittner opened the public hearing on the 2021 proposed ad valorem tax rate of .4700 per \$100.00 of appraised property value. With no one present to speak in favor of or in opposition to the proposed rate, Mayor Kittner closed the public hearing.

6. DISCUSSION AND CONSIDER ACTION ON ORDINANCE 21-07, ADOPTING THE 2021 AD VALOREM TAX RATE

Dr. Oubre provided that the tax rate is made up of two components and those are "Operations and Maintenance" and "Interest and Sinking" which is due to the bond debt for the Woodway Family Center.

Maintenance and Operations: .445378 Interest and Sinking: .024622 2021 Ad Valorem Tax Rate: .470000

The property tax rate will be increased by the adoption of a tax rate of .4700/\$100 of appraised property value.

Councilmember Cook moved that the property tax rate be increased by the adoption of a tax rate of 0.470000, which is effectively a 11.69 percent increase in the tax rate. Councilmember Mercer seconded, Mayor Kittner read aloud the caption of the ordinance as required. Voting in favor: Mayor Kittner, Councilmember Qourzal, Councilmember Mercer, Councilmember Russell and Councilmember

Cook. The motion passed unanimously by the Councilmembers present.

7. DISCUSSION AND CONSIDER ACTION ON ORDINANCE 21-08, AMENDING CHAPTER 2, ADMINISTRATION, SECTION 2-5, CLASSIFICATION AND COMPENSATION PLAN ADOPTED, OF THE CITY OF WOODWAY CODE OF ORDINANCES

Dr. Oubre provided comments.

Mayor Pro Tem Giddings arrived to the meeting at 5:45 p.m.

Councilmember Russell moved to adopt Ordinance 21-08, amending Chapter 2, Administration, Section 2-5, Classification and Compensation Plan Adopted, of the City of Woodway Code of Ordinances. Councilmember Cook seconded, Mayor Kittner read aloud the caption of the ordinance as required, and the motion passed unanimously by the Councilmembers present.

- 8. DISCUSSION AND CONSIDER ACTION ON RESOLUTION R-21-12, AMENDING THE CITY OF WOODWAY MASTER FEE SCHEDULE
- Dr. Oubre provided comments.

Councilmember Mercer moved to adopt Resolution R-21-12, amending the City of Woodway Master Fee Schedule. Councilmember Russell seconded, and the motion passed unanimously by the Councilmembers present.

PUBLIC HEARINGS AND RELATED ACTION

9. A. PUBLIC HEARING ON APPLICATION TO DEVELOP IN A PLANNED DISTRICT (TAKE 5 OIL CHANGE) LOT 1, BLOCK 1, OF THE JACK IN THE BOX ADDITION TO THE CITY OF WOODWAY, MCLENNAN COUNTY, TEXAS, LOCATED AT 201 HEWITT DR.

Dr. Oubre stated this is the final step in the application to develop. This is the old Jack in the Box property at the edge of the city limits. It will cause a demolition of the existing building with a reconstruction of the Take 5 Oil Change. There is a representative here from the engineering firm for any questions. The first required public hearing was held on August 10th at the Planning and Zoning meeting. Planning and Zoning recommends approval.

Mayor Kittner opened the public hearing. Mr. Derek Williams, Director of Real Estate of Take 5 Oil Change, 5620 Pershing Avenue, Fort Worth, Texas spoke in favor and provided information regarding the business and the services offered.

With no one else present to speak in favor of or in opposition to the application, Mayor Kittner closed the public hearing.

Mayor Pro Tem Giddings moved to approve the request for an Application to Develop in a Planned District (Take 5 Oil Change) on Lot 1, Block 1, of the Jack in the Box Addition to the City of Woodway, McLennan County, Texas, located at 201 Hewitt Drive, Woodway, Texas. Councilmember Russell seconded, and the motion passed unanimously by the Councilmembers present.

10. A. PUBLIC HEARING ON APPLICATION FOR CHANGE IN ZONING CLASSIFICATION FROM "P-C" PLANNED COMMERCIAL TO "R-1" SINGLE FAMILY RESIDENTIAL OF LOT 10B, 12A, BLOCK 7, 8, OAKDALE ADDITION TO THE CITY OF WOODWAY, MCLENNAN COUNTY, TEXAS, LOCATED AT 844 WHITE OAK

Dr. Oubre provided that this went to the Planning and Zoning Commission on August 10th for the first required public hearing. Mr. Ramirez, the applicant is available for any questions.

Mayor Kittner opened the public hearing. Mr. Alejandro Ramirez, 1270 Circlewood Drive, Woodway stated that he has been living in Woodway for four years and loves it here. The lot has some challenges and wants to build his residence on this property.
