CALL MEETING TO ORDER

Mayor Kittner called the meeting to order at 5:30 p.m.

INVOCATION

1. INVOCATION

Councilmember Qourzal provided the invocation.

PRESENTATIONS AND VISITORS

2. QUARTERLY PRESENTATION - COMMUNITY SERVICES AND DEVELOPMENT

Director Mitch Davison presented the Community Services and Development quarterly report covering July through September, 2021. He reviewed several photographs provided on a PowerPoint presentation of current residential development around the City along with the following commercial projects: Republic Gun Club and H.O.T. Smiles. He also stated that inspections in general are busy and still seeing a lot of development. There were no questions.

Dr. Oubre provided that Badger Ranch Phase 6 is not a part of the Badger Ranch HOA. Because they are not a part of the HOA, they are not installing sidewalks. We are getting questions as to why there are no sidewalks going down to the school. We have also received requests for school crossings in this general area around South Bosque School.

PUBLIC HEARINGS AND RELATED ACTION

4. A. Public hearing on approval of Application to Develop in a Planned District (renovations to a metal building for office and warehouse use) Lot a12, Block A, of the Woodway Center North Addition to the City of Woodway, McLennan County, Texas, located at 6807 Woodway Drive

Mayor Kittner asked Mayor Pro Tem Giddings to handle this item because she has filed a Conflict of Interest Affidavit with the City Secretary.

Mayor Pro Tem Giddings opened the public hearing. Mr. Travis Fagg, 207 N. 40th St., Waco, Texas, spoke in favor of the item. He is the Managing Partner for Texas Document Solutions that has signed a lease on this property since March. They were originally at 6700 Woodway Drive, and after a two-year search for a possible location settled on this location because it doubled the size. The parking lot is very small and butts right up against TxDOT, so we are asking for a modification to the berm ordinance and the second modification we are asking for is the dumpster screening. The dumpster cannot be seen from Highway 84 or Old McGregor because it is hidden behind the building.

With no one else speaking in favor nor in opposition, Mayor Pro Tem Giddings closed the public hearing.

B. DISCUSSION AND CONSIDER ACTION ON APPROVAL OF APPLICATION TO DEVELOP IN A PLANNED DISTRICT (RENOVATIONS TO A METAL BUILDING FOR OFFICE AND WAREHOUSE USE) LOT A12, BLOCK A, OF THE WOODWAY CENTER NORTH ADDITION TO THE CITY OF WOODWAY, MCLENNAN COUNTY, TEXAS, LOCATED AT 6807 WOODWAY DRIVE

Dr. Oubre provided that the Planning and Zoning Commission heard this item on September 28th. There were no negative comments to the proposal. The Planning and Zoning Commission recommended the modifications for your consideration.

There was a brief discussion regarding the requests for the modification of the berm and dumpster screening and the requirements of the ordinances. After the discussion, the Council felt it was necessary to have two motions on each modification request.

Councilmember Russell moved to approve the request for the berm variance and the Application to Develop in a Planned District (renovations to a metal building for office and warehouse use) on Lot A12, Block A, of the Woodway Center North Addition to the City of Woodway, McLennan County, Texas, located at 6807 Woodway Drive. Councilmember Mercer seconded the motion, and the motion passed unanimously by the councilmembers present.

Councilmember Mercer moved to disapprove the variance request for the dumpster screening on the Application to Develop in a Planned District (renovations to a metal building for office and warehouse use) on Lot A12, Block A, of the Woodway Center North Addition to the City of Woodway, McLennan County, Texas, located at 6807 Woodway Drive. Councilmember Qourzal seconded the motion, and the motion passed unanimously by the councilmembers present

5. DISCUSSION AND CONSIDER ACTION ON RESOLUTION R-21-14, A RESOLUTION OF CANDIDATE NOMINATIONS FOR THE MCLENNAN COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS FOR THE YEARS 2022-2023

Dr. Oubre provided information on this item. Once the nominations are received the Chief Appraiser will send the ballot with all the nominations to vote on and the top five will be the newly elected board members. At a staff level, we have a recommendation if you are open to it. Her name is Bridgette Fuselier and she is currently the Dean or Professor of Real Estate at Baylor Law. Dr. Caballero knows her and she has shown an interest when we talked about being on the Appraiser Review Board.

There were a few questions and a brief discussion.

Mayor Pro Tem Giddings moved to adopt Resolution R-21-14, nominating Bridgette Fuselier to be considered for election to the McLennan County Appraisal District Board of Directors for the years 2022-2023. Councilmember Avant seconded the motion, and the motion passed unanimously by the councilmembers present.

6. DISCUSSION AND CONSIDER ACTION TO AUTHORIZE CITY MANAGER TO HIRE LAN ENGINEERING TO DEVELOP A SCOPE OF WORK AND OTHER NECESSARY SERVICES TO BID PROJECT FOR DRAINAGE ISSUES ON RIVERVIEW

Dr. Oubre provided information and possible recommendations. He also stated that this is one of those projects you don't have to do. It is not the fault of the City nor are we the cause of the problem. Mitch and I did a site visit at 13079 Riverview and there is a long history with Mr. and Mrs. Reid as far as a draining issue goes.

We have used LAN for a previous drainage project. Doing this engineering step does not commit us to doing a turn key project. It just commits us to finding out what the best available options are.

There were a couple of questions and a brief discussion.

Councilmember Qourzal moved to authorize the City Manager to hire LAN Engineering to develop a scope of work and other necessary services to bid project for drainage issues on Riverview. Councilmember Russell seconded the motion, and the motion passed unanimously by the councilmembers present.
