As you know, the Economic Development Committee has met several times on the proposed overlay and the Council had a workshop last week on this as well. There were some adjustments made at that time. Tonight, the Council needs to decide what the overlay district parameters are going to be. We will then ask at a later date the zoning within the overlay. At the workshop, we did discuss a moratorium, however, after discussions with the City Attorney, that will not be applicable to us because we don't meet the requirements necessary.

Dr. Caballero provided additional information on the proposed overlay map.

The City Council reviewed the proposed overlay map and discussed the possible boundaries.

Councilmember Mercer, (Chair of the Economic Development Committee) stated that the purpose of the overlay is to protect and preserve the integrity of how we want the Highway 84 Corridor to be, not just today, but in fifty years.
