Mayor Kittner called the meeting to order at 5:30 p.m.

2. QUARTERLY PRESENTATION – FINANCE DEPARTMENT

William Klump, Finance Director, presented the quarterly report for the Finance Department. He stated that we are halfway through the fiscal year which ended March 31, 2022. Mr. Klump discussed the general fund revenues and expenses, utility fund revenues and expenses, and tourism fund revenues and expenses.

There were no questions.

# **DISCUSSION AND CONSIDER ACTION**

3. DISCUSSION AND CONSIDER ACTION ON AUTHORIZING CITY MANAGER TO AMEND AND EXTEND THE SOLID WASTE COLLECTION AND DISPOSAL CONTRACT WITH FRONTIER WASTE SOLUTIONS

The Mayor called for a motion. Mayor Pro Tem Giddings moved to open this item for discussion and Councilmember Qourzal seconded.

Dr. Oubre provided that the end of May of this year will be the end of the first five years of the current agreement which started on June 1, 2017. This was brought before council in February to discuss and negotiate an extended agreement. Tonight, we have the negotiated agreement. Effective June 1, 2022 we will start a new five-year agreement.

There were a few comments and a brief discussion.

Mr. Tim Henderson with Frontier Waste Solutions answered questions.

Mayor Pro Tem Giddings moved to authorize the City Manager to amend and extend the Solid Waste Collection and Disposal contract with Frontier Waste Solutions. Councilmember Cook seconded, and the motion passed unanimously.

4. DISCUSSION AND CONSIDER ACTION ON MINUTES OF THE REGULAR CITY COUNCIL MEETING HELD APRIL 11, 2022, AT 5:30 P.M.

The Mayor called for a motion. Mayor Pro Tem Giddings moved to open this item for discussion and Councilmember Avant seconded.

There was no discussion.

Mayor Pro Tem Giddings moved to approve the minutes of the regular City Council meeting held April

- 11, 2022, at 5:30 p.m. Councilmember Cook seconded, and the motion passed unanimously.
- 5. DISCUSSION AND CONSIDER ACTION ON RESOLUTION R-22-09, CASTING VOTES TO ELECT A MEMBER OF THE GOVERNING BODY OF THE MCLENNAN COUNTY RURAL TRANSIT DISTRICT

The Mayor called for a motion. Councilmember Qourzal moved to open this item for discussion and Councilmember Cook seconded.

Dr. Oubre provided that this was discussed at the March 28<sup>th</sup> City Council meeting to nominate a member of Council to the pool of candidates. The ballot lists three candidates and the Council is instructed to disburse 20 votes between the three with the maximum of ten towards Councilmember Mercer. The three candidates are: Charles Turner (Hewitt), Steven Dutschmann (McGregor) and David Mercer (Woodway).

There was a brief discussion to determine how to disburse the votes.

Councilmember Cook moved to cast their votes as five for David Mercer, seven for Charles Turner and eight for Steven Dutschmann and adopt Resolution R-22-09, casting these votes to elect a Member of the Governing Body of the McLennan County Rural Transit District. Councilmember Russell seconded and the motion passed unanimously.

6. A. PUBLIC HEARING ON APPLICATION TO DEVELOP IN A PLANNED DISTRICT (U-HAUL MOVING & STORAGE) LOT 19, BLOCK 10, OF THE WOODWAY CENTER ADDITION TO THE CITY OF WOODWAY, MCLENNAN COUNTY, TEXAS, LOCATED AT 211 COLONNADE PARKWAY

Mayor Kittner opened the public hearing.

Matt Merrill, the applicant, 200 Central Texas Parkway, spoke in favor of the application. He provided that he was there to answer any questions for this development and this is to expand on their existing facility.

Adam Ylitalo, 207 Settlers Creek, Waco, Texas spoke in opposition of the U-Haul storage facility next to his development of Wheelhouse Bats Bar and Grill to include a restaurant, pickle ball courts, batting cages, outdoor lawn games and a family friendly area. Woodway does not have much real estate undeveloped and that can still be developed in restaurants/entertainment. He strongly opposes the U-Haul Self-Storage units going in next door to his development.

Lori Whitsell, 401 Woodfall Drive, Woodway, Texas. Not opposed to U-Haul but doesn't think it is a good location for U-Haul and agrees that the City needs more family friendly places.

With no one else to speak in favor or in opposition, Mayor Kittner closed the public hearing.

6. B. DISCUSSION AND CONSIDER ACTION ON APPLICATION TO DEVELOP IN A PLANNED DISTRICT (U-HAUL MOVING & STORAGE) LOT 19, BLOCK 10, OF THE WOODWAY CENTER ADDITION TO THE CITY OF WOODWAY, MCLENNAN COUNTY, TEXAS, LOCATED AT 211 COLONNADE PARKWAY

Dr. Oubre provided that the Planning and Zoning heard this at their April 12<sup>th</sup> meeting which included the first required public hearing. This property is zoned industrial which allows this type of construction. The other properties are zoned commercial. Staff recommends approval of this project.

There were questions answered by the Applicant, Mr. Merrill.

Mike Dixon, City Attorney provided comments regarding the project being located in an area that it is zoned for.

The applicant stated that the majority of that property is going to house the building and there is a small area that will be open and they are discussing putting additional landscaping or something to help.

There was discussion.

Mr. Trent Neuman, 3626 Castle, Waco, Texas, stated that he and Adam are partners on the adjacent property. They are not arguing that the building is not going to look visually nice. Their concerns are they will be surrounded in an industrial area and their restaurant will get choked out. They were hoping to attract more "like businesses" since they will be investing in that area.

Mayor Pro Tem Giddings moved to approve the request of an Application to Develop in a Planned District (U-Haul Moving & Storage) Lot 19, Block 10, of the Woodway Center Addition to the City of Woodway, McLennan County, Texas, located at 211 Colonnade Parkway with modifications of landscaping on the side of Wheelhouse Bats Bar and Grill. Councilmember Avant seconded and the motion passed six to one with Councilmember Mercer voting against.

Councilmember Cook moved to approve the Application to Develop in a Planned District (Floorco) Lot 4, Block 1, of the Florence Moore Addition to the City of Woodway, McLennan County, Texas, located at 16000 Woodway Drive. Councilmember Russell seconded and the motion passed with a six to one vote with Councilmember Mercer voting against.

Randy Robison, Robison Construction spoke in favor of this application. He answered questions.

With no one additional speaking in favor or in opposition, Mayor Kittner closed the public hearing.

Dr. Oubre provided information and an aerial view of the property being discussed. The Planning and Zoning heard this at the first required public hearing on April 12<sup>th</sup> and recommends approval of this application. This is properly zoned for the proposed project. Staff recommends approval.

Mayor Pro Tem Giddings moved to approve the Application to Develop in a Planned District (retail shell building) Lot 6, Block 8, of the Woodway Center Addition to the City of Woodway, McLennan County, Texas, located at 193 Archway Drive. Councilmember Qourzal seconded and the motion passed with a six to one vote with Councilmember Mercer voting against.

With no one speaking in favor or opposition of the application, Mayor Kittner closed the public hearing.

Dr. Oubre provided information and an aerial view of this property and a list of businesses that can occur in Planned Commercial zoning. He also stated that there were at least four area property owners that spoke in opposition of this change in zoning request at the Planning and Zoning meeting. Planning and Zoning Commission voted against this request.

Nancy Goebel, 14009 Horseshoe Circle, questioned the zoning. Mayor Kittner responded with what the current zoning is and what Planned Commercial zoning would mean.

Mayor Pro Tem Giddings moved on the recommendation of the Planning and Zoning Commission to disapprove amending the City of Woodway Future Land Use Plan of Lot 1, Block 1, Estates Drive Addition to the City of Woodway, McLennan County, Texas, located at 405 Estates Drive, from "R-1" Residential to "P-C" Planned Commercial. Councilmember Russell seconded and the motion passed unanimously.
