Mayor Qourzal called the meeting to order at 5:30 p.m.

2. QUARTERLY PRESENTATION – PUBLIC SAFETY DEPARTMENT

Chief Crook presented the quarterly report. This is the quarterly comparison statistics for July 1 – September 30, 2021 and July 1 – September 30, 2022. He discussed statistics for Police Calls for Service, Fire/EMS Calls for Service, VCO Calls for Service, Traffic Stops, Citations, Accidents, Arrests, Online Solicitations, Thefts, Assaults and Weapon Violations.

The top four offenses during this time period in 2022 were Driving Under the Influence, Drug/Narcotic Violation, All other Larceny and Destruction/Damage/Vandalism.

Chief Crook also reported that they are looking at moving to electronic ticket writers. Questions were answered.

3. QUARTERLY PRESENTATION – COMMUNITY SERVICES AND DEVELOPMENT

Assistant Director John Norman presented the Community Services and Development quarterly report covering July through September 2022. He reviewed several photographs provided on a PowerPoint presentation of current residential development around the City, along with the following commercial projects: Dutch Bros at 9000 Jordan Lane, Retail Space at 9111 Jordan Lane and U-Haul at 211 Colonnade. Quarterly figures were attached for purposes of inspections. Mr. Norman answered questions.

Dr. Oubre provided that Steve Sorrells is the applicant for this project and he has already done a couple of buildings in this general area. It is zoned commercial and at the first public hearing during the

Staff recommends approval.

Councilmember Russell moved to approve the request of an Application to Develop in a Planned District (Office Buildings) Lot 1, Block H, of the Condo SDC Badger Ranch Office, Badger Ranch Addition to the City of Woodway, McLennan County, Texas, located at 15190 Badger Ranch Blvd. Councilmember Gilman seconded, and the motion passed by a five to one vote with Mayor Pro Tem voting against the application.

Mayor Qourzal called for a motion to discuss. Councilmember Russell moved to open this item for discussion and Councilmember Gilman seconded.

Dr. Oubre provided that this is to start the process to have a target start date for the construction of the Woodway Family Center.

Dr. Caballero provided additional information. Artist renderings of the Woodway Family Center were provided. He also stated that representatives from John Erwin Construction and RBDR Architects were in attendance to answer any questions.

There was a brief discussion.

Dave Keyston, (citizen), 400 Shadow Mountain asked if the two basketball courts shown on the rendering, could be repurposed for other types of play, such as pickle ball? Dr. Caballero responded that the courts can be re-striped to use for other games.

Councilmember Gilman moved to authorize the City Manager to accept the 10-Day Notice to Proceed and construction agreements between the City and Construction Manager for the Woodway Family Center construction project. Councilmember Williams seconded, and the motion passed unanimously by the councilmembers present.

Mayor Qourzal called for a motion to discuss. Councilmember Russell moved to open this item for discussion and Councilmember Williams seconded.

Dr. Oubre reported that the City Council Economic Development Committee has been working on this for a couple of years.

Councilmember Gilman (Chair of the Economic Development Committee) provided comments relating to the Highway 84 Overlay District and proposal for rezoning the land needed for future growth of the corridor. A plan is needed to preserve, protect and enhance the character of the corridor property values and the economic viability along the corridor by managing for growth and development. She also stated that if we want to change a zone, we have to have a current comprehensive master plan. The Economic Development Committee which consists of Mayor Qourzal, Councilmember Russell and Councilmember Gilman recommends authorizing the City Manager to enter into a professional service agreement with Kimley-Horn and Associates for consulting and urban planning of the Highway 84 Overlay District along with updating the City's Comprehensive Master Plan not to exceed \$200,000.00.

Councilmember Russell provided additional comments.

Councilmember Russell moved to authorize the City Manager to enter into a professional service agreement with Kimley-Horn and Associates, Inc., for consulting and urban planning of the Highway 84 Overlay District along with updating the City's Comprehensive Master Plan in an amount not to exceed \$200,000.00. Councilmember Williams seconded, and the motion passed unanimously by the Councilmembers present.
