CALL MEETING TO ORDER

Mayor Qourzal called the meeting to order at 6:37 p.m.

ITEMS FOR INDIVIDUAL DISCUSSION, CONSIDERATION AND/OR ACTION

1. DISCUSSION AND CONSIDER ACTION ON YEAR-END BUDGET TRANSFERS

Mayor Qourzal called for a motion to discuss. Councilmember Avant moved to open this item for discussion and Councilmember Williams seconded.

Dr. Oubre provided that each year there are some left over funds in the general fund, utility fund and hotel/motel tax fund. We put those funds into capital project funds for each of those divisions.

Staff is asking to transfer 1,300,000 from the General Fund to the General Capital Projects Fund; transfer \$300,000 from the Utility Fund to the Utility Capital Projects Fund; and transfer \$149,061 from the Tourism Fund to the Arboretum Construction Fund for foundation and drainage repairs at the Pavilion that were approved by City Council in FY 2022.

Councilmember Cook moved to authorize the year end transfers as recommended by staff, Councilmember Gilman seconded, and the motion passed unanimously.

2. DISCUSSION AND CONSIDER ACTION ON AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH ALAN BOJORQUEZ, BOJORQUEZ LAW FIRM, P.C., ENGAGING HIS LEGAL SERVICES TO ASSIST IN THE REDISTRICTING PROCESS FOR THE CITY OF WOODWAY VOTING WARDS

Mayor Qourzal called for a motion to discuss. Councilmember Avant moved to open this item for discussion and Councilmember Cook seconded.

Dr. Oubre provided comments regarding the three voting wards. The City Charter requires that the voting precincts for the City shall be established and designated from time to time by Ordinance to be balanced as possible for each ward. In order to fulfill the obligation of the City Charter, we need to re-evaluate and move the lines. He has contacted three attorneys who specialize in redistricting and is recommending hiring Alan Bojorquez.

Councilmember Cook moved to authorize the City Manager to enter into an agreement with Alan Bojorquez, Bojorquez Law Firm, P.C., engaging his legal services to assist in the redistricting process for the City of Woodway voting wards. Councilmember Williams seconded, and the motion passed unanimously.
