BID #21-07 CITY OF WOODWAY BUSH DRIVE ROADWAY IMPROVEMENTS

Sealed bids addressed to the City Secretary of the City of Woodway will be received until 3:00 PM, Thursday, December 2, 2021 at Woodway City Hall, 922 Estates Drive, Woodway, Texas 76712 and publicly opened and read aloud at that time, for constructing the following project:

City of Woodway Bush Drive Roadway Improvements

Demolition and reconstruction of approximately 2,600 sy of Bush Drive in the City of Woodway, Texas. New pavement section will be 9 inches of continuously reinforced concrete pavement on top of 6 inches of crushed limestone base material. Other improvements include minor ditch grading and concrete culvert replacement.

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to the City Secretary, and the outside of the envelope must be marked **BID ENCLOSED** – BUSH DRIVE ROADWAY IMPROVEMENTS. All bids must be made on blank forms provided and included in the bound document. The name and address of the Bidder must be plainly marked thereon.

Each bid must be accompanied by cash or a certified cashier's check, drawn on a bank or trust company authorized to do business in the State of Texas, payable to City of Woodway in an amount at least equal to five percent (5%) of the total amount of the bid, as a guarantee that a contract will be entered into. In lieu of cash or a certified check, the Bidder may submit a bid bond in the form prescribed in paragraphs 5.01 and 5.02 of the General Conditions.

Bidding Documents are on file and may be examined at City of Woodway located at 924 Estates Dr. Woodway, Texas 76712.
